SERVICES INCLUDE MEDICAL EXAMS, FORENSIC INTERVIEWS, CRISIS INTERVENTION, PYSCHOLOGICALS, PSYCHOSOCIAL ASSESSMENTS, CASE COORDINATION AND EXPERT COURT TESTIMONY. THESE SERVICES ARE AVAILIABLE 24 HOURS A DAY/SEVEN DAYS A WEEK FREE OF CHARGE. CHILDREN ARE REFERRED BY DEPARTMENT OF CHILDERN AND FAMILIES AND LAW ENFORCEMENT.

TREATMENT OPTIONS INCLUDE INDIVIDUAL, GROUP, AND FAMILY THERAPY. THE GOALS OF THE PROGRAM ARE TO ASSIST CLIENTS IN OVERCOMING ABUSE-RELATED BEHAVIORAL AND EMOTIONAL DIFFICULTIES AND TO HELP CLIENTS DEVELOP EFFECTIVE COPING SKILLS, HEALTHY SOCIALIZAITON SKILLS, AND SAFETY PLANNING SKILLS.
